

PARTICIPANT TRAVEL WAIVER & RELEASE OF LIABILITY

Organized by Hotel Resort Discounts LLC (“Agency”)

1. Participation Acknowledgment

I understand that participation in this group trip, retreat, or hosted experience is voluntary. Hotel Resort Discounts LLC (“Agency”) provides coordination, registration, payment administration, and communication services only.

The Agency does not own, operate, manage, supervise, or control hotels, resorts, airlines, ground transportation providers, instructors, hosts, excursion operators, or other third-party vendors.

2. Assumption of Risk

I acknowledge that travel, including international travel, involves inherent risks, including but not limited to illness, injury, accidents, theft, weather events, transportation disruptions, vehicle-related incidents, delays, and participation in physical, recreational, or wellness-related activities.

I voluntarily assume all risks, whether known or unknown, foreseeable or unforeseeable, associated with my participation in the trip.

3. Release of Liability

I release, waive, and hold harmless Hotel Resort Discounts LLC, its owners, officers, employees, contractors, affiliates, and service providers from any and all claims, demands, injuries, losses, damages, costs, or liabilities arising from my participation in the trip, whether caused by negligence or otherwise, to the fullest extent permitted by law.

This includes, without limitation, claims related to accommodations, transportation, physical activities, instruction, excursions, personal vehicles, third-party services, or acts or omissions of hotels, instructors, organizers, vendors, or other participants.

4. Organizer & Instructor Disclaimer

I acknowledge that organizers, hosts, instructors, and experience leaders are independent parties and are not employees, partners, agents, or representatives of the Agency.

The Agency does not supervise, manage, direct, or control instruction methods, activity programming, schedules, participant conduct, or outcomes.

5. Instructor Availability & Experience Substitution Acknowledgment

I understand and agree that any instructor, host, or experience leader referenced or advertised in connection with this trip may become unavailable due to illness, travel disruption, personal circumstances, or other factors beyond the Agency's control.

If the originally referenced instructor or host is unable to attend, I acknowledge and agree that the trip will proceed as scheduled. The experience component of the trip may be fulfilled, at the Agency's reasonable discretion, through one or more of the following:

- A replacement instructor approved by the Agency
- An independent local instructor or service provider
- Modified, alternative, or resort-facilitated wellness or group activities
- Adjusted or reduced experience programming

I agree that any such substitution or modification constitutes fulfillment of the experience portion of the trip and does not constitute a cancellation, material change, or breach of agreement.

I further acknowledge that instructor substitution, modification, or adjustment does not entitle me to refunds, credits, chargebacks, or other compensation.

6. Participant Responsibilities

I agree to:

- Possess valid passports, visas, and required travel documents
- Provide accurate personal information

- Disclose relevant medical, physical, or dietary needs in advance
- Comply with resort rules, transportation requirements, and local laws
- Act responsibly and respectfully during the trip

Unsafe, disruptive, or unlawful behavior may result in removal from the trip without refund.

7. Physical Activities, Wellness & Medical Disclaimer

I understand that yoga, wellness, fitness, or movement-based activities involve physical exertion. I confirm that I am physically and medically able to participate.

I acknowledge that the Agency does not provide medical advice, screening, supervision, or health assessments. I voluntarily assume full responsibility for my participation and any resulting injury, illness, or discomfort.

8. Ground Transportation & Personal Vehicles

I acknowledge that travel may involve ground transportation such as shuttles, buses, taxis, or personal vehicles.

If I choose to drive or arrange transportation independently, I assume full responsibility for timing, vehicle condition, parking, compliance with laws, and safety. The Agency is not responsible for accidents, delays, routing decisions, missed transfers, or incidents related to independently arranged transportation.

9. Optional Activities, Hotel Inclusions & Third-Party Services

Optional activities, excursions, and services are operated by independent third-party providers. Participation is voluntary and undertaken at my own risk.

Hotel inclusions such as meals, service formats, group functions, or amenities are provided solely according to the hotel or resort's standard offerings for the specific trip.

Private events, customized menus, special setups, upgrades, or non-standard services may incur additional costs and are not included unless clearly communicated in writing in advance.

10. Indemnification

I agree to indemnify, defend, and hold harmless the Agency from any claims, damages, losses, costs, or expenses (including reasonable legal fees) arising from my actions, omissions, violations of law, or breach of this Waiver.

11. Airfare & Trip Confirmation Acknowledgment

I understand that submitting a deposit does not confirm the trip. I agree not to book airfare until trip confirmation is issued by the Agency.

Booking airfare prior to confirmation is done at my own risk.

12. Cancellation & Refund Acknowledgment

I understand and agree that once a trip is confirmed:

- Deposits become non-refundable
- Mid-payments and final payments are non-refundable
- No credits, rollovers, or refunds apply

This Waiver is in addition to, and does not replace, the Agency's published Terms & Conditions.

13. Force Majeure

I acknowledge that events beyond the Agency's control may impact travel plans, including natural disasters, pandemics, government actions, labor disruptions, or transportation interruptions.

Refunds, if any, follow applicable vendor policies.
