

PARTICIPANT TRAVEL WAIVER & RELEASE OF LIABILITY

Organized by Hotel Resort Discounts LLC (“Agency”)

1. Participation Acknowledgment

I understand that participation in this group trip, retreat, or hosted experience is voluntary. The Agency provides coordination services only and does not own, operate, manage, supervise, or control hotels, resorts, airlines, ground transportation providers, instructors, excursion operators, or other third-party vendors.

2. Assumption of Risk

I acknowledge that travel, including international travel, involves inherent risks, including but not limited to illness, injury, accidents, theft, weather events, transportation disruptions, vehicle-related incidents, delays, and participation in physical, recreational, or wellness-related activities.

I voluntarily assume **all risks**, whether known or unknown, foreseeable or unforeseeable, associated with my participation.

3. Release of Liability

I release, waive, and hold harmless Hotel Resort Discounts LLC, its owners, officers, employees, contractors, affiliates, organizers, instructors, hotels, transportation providers, and third-party vendors from **any and all claims, demands, injuries, losses, damages, costs, or liabilities**, including those arising from **negligence**, related to my participation in the trip, including but not limited to air travel, ground transportation, personal vehicles, accommodations, activities, or third-party services.

4. Organizer & Instructor Disclaimer

I acknowledge that organizers and instructors are independent parties and are not employees, partners, agents, or representatives of the Agency. The Agency does not supervise, manage, direct, or control activities, instruction, excursions, or participant conduct.

5. Participant Responsibilities

I agree to:

- Possess valid passports, visas, and required travel documents
- Disclose relevant medical, physical, or dietary needs in advance
- Comply with resort rules, transportation requirements, and local laws
- Act responsibly and respectfully during the trip

Unsafe, disruptive, or unlawful behavior may result in removal from the trip without refund.

6. Physical Activities, Wellness & Medical Disclaimer (If Applicable)

I understand that yoga, wellness, fitness, or movement-based activities involve physical exertion. I confirm that I am physically and medically able to participate.

I acknowledge that the Agency does **not** provide medical advice, screening, supervision, or health assessments, and I voluntarily assume full responsibility for my participation and any resulting injury, illness, or discomfort.

7. Ground Transportation & Personal Vehicles

I acknowledge that some travel may involve ground transportation, including shuttles, buses, taxis, or personal vehicles. If I choose to drive or arrange transportation independently, I assume full responsibility for my travel, timing, vehicle condition, parking, and safety.

The Agency is not responsible for accidents, delays, routing decisions, missed transfers, vehicle issues, or incidents related to personal or independently arranged transportation.

8. Optional Activities & Third-Party Services

Optional activities, excursions, and services are operated by independent third-party providers. Participation is voluntary and undertaken at my own risk. The Agency does not guarantee safety, quality, or outcomes.

9. Indemnification

I agree to indemnify, defend, and hold harmless the Agency from any claims, damages, losses, costs, or expenses (including reasonable legal fees) arising from my actions, omissions, violations of law, or breach of this Waiver.

10. Airfare & Trip Confirmation Acknowledgment

I understand that submitting a deposit does not confirm the trip and that I must not book airfare until receiving written confirmation from the Agency. Booking airfare prior to confirmation is done at my own risk.

11. Cancellation & Refund Acknowledgment

I understand that once a trip is confirmed:

- Deposits become non-refundable
 - Mid-payments and final payments are non-refundable
 - No credits, rollovers, or refunds apply
